Lastnosti / Properties:	Beli ali svetlo rumeni koščki ali ploščice, v tankem sloju prosojne, ob prelomu fino zrnate, matirane in neznate. Pri segrevanju v rokah postanejo mehke in voljne. Vonj spominja na rumen čebelji vosek, vendar je šibkejši in nikoli žarek. Je brez okusa in se ne prijema na zobe. Skoraj netopni v vodi, delno topni v vročem etanolu (90 odstotnem V/V) in popolnoma topni v maščobnih in eteričnih oljih. / <i>White or yellowish-white pieces or plates, translucent when thin, with a fine-grained, matt and non-crystalline fracture; when warmed in the hand they become soft and malleable. It has an odour similar to that of yellow beeswax, though fainter and never rancid.
